Virginia COVID-19 Resources for Landlords and Property Managers:

Through the Virginia Rent and Mortgage Relief Program (RMRP), [Virginia Housing](#) is administering financial assistance for renters experiencing financial difficulties due to the COVID-19 pandemic. Eligible landlords and property managers can apply on behalf of their tenants to receive financial assistance for past-due rental payments dating back to April 1, 2020. Funding for RMRP is through the federal and state resources.

Mayor Muriel Bowser and the Office of the Deputy Mayor for Planning and Economic Development launched new Housing Stabilization Grants with \$10 million from the federal CARES Act to provide COVID-19 related relief to District Housing Providers, with \$1 million set aside specifically for small housing providers. The program will be available to two groups:

Housing Stabilization Grants (Group A), administered by the DC Housing Finance Agency, will include housing providers in the city's portfolio of affordable housing projects financed by the Housing Production Trust Fund, Low Income Housing Tax Credits, or other local and federal affordable housing funds.

Group B, administered by the Department of Housing and Community Development, will include small housing providers with 20 units or fewer in their portfolio.

Rent arrears from April 1, 2020, through November 30, 2020, will be paid by the city to housing providers in an 80:20 split with the District contributing 80% of the rent, up to \$2,000 per unit per month, and the housing provider forgiving the rest. **Applications will open on December 1 and close on December 11.**

The Maryland Department of Housing & Community Development (DHCD) is administering \$10 million for the Assisted Housing Relief Program.

The Assisted Housing Relief Program is intended to help bring rental delinquencies current for those units and provide real relief for the tenants affected by the COVID-19 pandemic through direct payments to the eligible property management company.

Tenants in eligible properties will be credited a seven-month rent rebate which will eliminate their rental debt and the threat of eviction.

The program will be limited to rental units in multi-family projects financed by DHCD's Community Development Administration using state funds or federal resources, such as the Low-Income Housing Tax Credit program where the unit rent is controlled.
