



Appeal to BZA and MOU


September 2018: Neighbors for Responsible Government and ANC 3C appealed minor modifications made to the project

January 2019: DHS, DGS, ANC 3C, and NRG entered into an MOU on January 9th

The MOU requires that:


- DGS reduce the size of deck by 20% (from 1,000 square feet to 800 square feet).
- DGS add trees and shrubs around deck to create an additional noise buffer.
- The hours of use for deck and playground are limited to 7:00am-9:00pm.
- Amplified or unreasonably loud music played outside the shelter will be prohibited.
- Flood lights on deck and playground will be prohibited.

As a condition of the MOU, the ANC and NRG withdrew their appeals.



Construction Progress

- Current construction activities (January, February, March)
 - Concrete
 - The foundation system is completed, first floor cast in place, columns and walls complete, first floor concrete slab is completed, preparation for the second floor podium slab is in progress
 - Mechanical electrical Plumbing (MEP) subgrade
 - Electrical and plumbing conduits below the foot print of the building have been complete, Telecommunications infrastructure is in progress, Pepco primary duct bank has been installed, site preparation for the secondary duck bank and new transformer is in progress
 - Site
 - Site grading completed at building foot print, Site grading in progress around building foot print continues as weather permits.
- Projected construction activities (April/May/June)
 - Elevated concrete slabs, third floor to the roof, Structural panel installation, third floor to 6th floor, MEP rough in, Door frame installations, New Pepco Transformer.


Good Neighbor Protocol Timeline

Progress to date:

- November: Advisory Team established process and timeline for drafting GNA
- <u>February:</u> Community forum hosted to collect feedback on GNA
- May: Advisory Team reviewed feedback collected at community forum
- May August: Designated Advisory Team members contributed further edits to the draft document

Current Status:

Good Neighbor Protocol is ready for review and comments.






Questions from the Advisory Team
