Construction Update

The concrete pour of walls and floors have been completed and interior framing has started at all floor levels. Contractors are working on mechanical, electrical, and plumbing. The frames for windows are projected to install in the next 2 weeks. The building is projected to be weather tight around the end of March. The building is still tracking for a summer 2019 substantial completion.

Health clinic update

The new RFO for the clinic space is open. There was a pre-bid meeting on Feb 15. Questions were due Feb 22 and proposals are due April 5.

DGS is currently finalizing the lease extension for Unity Clinic in the Joy Evans swing space.

Good Neighbor Protocol

Jay walked the team through the comments received from the community meeting in January. The team addressed comments and made necessary modifications to the protocol. The latest version of the protocol will be sent around for the group to finalize in the coming weeks.

Future Meetings and Site Visit
