

# Winter Plan Summary for Single Adults - Consumers

The District remains committed to ensuring access to shelter during hypothermia season and doing so in a way that is safe during the COVID-19 pandemic.

An open shelter may be full on any given night. Unless you have a bed at a shelter, call the Shelter Hotline (202-399-7093 or 311) to ensure you are directed to a shelter with availability.

Year-Around Shelters: All year-around shelters will continue to operate 24/7.

• Three meals a day will be provided onsite and individuals will keep their same beds.

<u>Seasonal Shelters</u>: Alert Night Shelters will operate as Seasonal Shelters and will be open 24/7. They will come online in two phases as beds are needed, therefore individuals should call the shelter hotline to find out where beds are available.

- Phase 1 shelters will come online the first night a hypothermia alert is called unless otherwise noted on page 2<sup>1</sup>, and
- Phase 2 shelters will come online as Phase 1 facilities approach maximum capacity.
- Once brought online, seasonal shelters will remain open throughout the rest of the season.
  - Meals will be provided onsite, and individuals will keep their same beds.

Overflow Shelters: Will be opened only when all other shelters are at or near capacity.

### Additional Safety Measures at Shelters:

- COVID screenings will occur daily on site and referrals to isolation or quarantine offered for those who have COVID-like symptoms or known exposure.
- Each shelter has reduced its capacity to increase social distancing.
- All meals will be "grab and go" and individuals will keep their same beds each night.
- All locations will have increased staffing and enhanced janitorial services.

<u>Transportation</u>: There will not be scheduled transportation to and from shelters. On-demand transportation will be prioritized for clients newly experiencing homelessness, and clients newly seeking shelter (e.g., individuals staying in an unsheltered location).

- On-demand transportation can be accessed by calling the Shelter Hotline.
- Wait times will depend on call volume, weather conditions, and location of pick-ups.
- If you are using shelter and need transportation to conduct essential business, please speak with a shelter case manager.

<u>Hypothermia Alerts:</u> Although shelters will be operating 24/7 and hypothermia alerts will not change the sites available, after the seasonal shelters open DHS will continue to monitor the weather and call alerts. <u>Outreach</u>: DHS outreach teams will extend hours until 9pm on non-alert nights and 11pm on hypothermia alert nights and will focus on triaging safety concerns and connections to shelter.
